Candidates should apply in the prescribed format (enclosed) for participating in the programme directly to the Coordinator of the programme.

The application should reach by post & Email (Advance copy) duly signed and scanned through E-mail as mentioned in table immediately but not later than the date mentioned in the table.

The selection of the candidates will be subject to the following guidelines:

- 1. Participants should attend all the sessions on all six days of the program. Participation certificate will be issued on the last day only after completion of the program.
- 2. Arrangements for accommodation, food etc. will be provided by the institute.

- 3. Participants should produce the original tickets or receipts for payment of TA charges. Actual fare will be reimbursed subject to eligibility limiting maximum up to 2 tier A.C. Rail fare as per the conditions and guidelines of CME Programme.
- 4. The application should be countersigned and duly certified by the head of the institution/Controlling authority to the effect that the candidate is a regular Ayurveda Medical Officer in the concerned state/College and that he/she has not attended more than one such program (CME) during the current year.
- 5. Participants should enclose self-attested copies of educational qualification, State/CCIM Registration Certificate & Original Identity Card of the Institute /Working Place along with the application.
- 6. Application not containing full Bio-data including Name, Address with Pin Code, Phone No.(Land & Mobile) and E-mail ID/FAX, will not be considered.
- 7. Only those candidates whose selection will be confirmed by this Institute should be deputed for the training.
- 8. Application must mention "Application for CME for Ayurved Medical Officer" on top of the envelope.
- 9. Selected trainees will be intimated immediately after completion of selection procedure and then they can make their journey tickets.
